CROSS REGISTRATION (TO OTHER INSTITUTION)

The University of the Philippines shall give no credit for any course taken by any of its students in any other university, college, or school unless the taking of such course was expressly authorized by the Vice-President for Academic Affairs [Under E.O. No. 1 dated 13 March 1984 and EO No. 2 dated 14 March 1984, the authority of the Vice President for Academic Affairs specified therein has been delegated to Chancellors. (UPD Faculty Manual 2003) However, the authority of the Chancellor has been delegated to the University Registrar per Memorandum FN 90-12 dated 07 Mar 1990] on the recommendation of the Dean concerned. The authorization shall be in writing to be recorded by the University Registrar or by his representative, and shall specifically describe the subjects authorize. [Art 336, amended at these BOR meetings: 790th, 19 December 1969 and 861st, 29 May 1975]

Courses taken outside the University are subject to validation.

NOTE:


Cross-registration to another institution may be authorized if the student is graduating and the course necessary for graduation is not being offered in UP Visayas in that particular semester. It is up to the Program Adviser, Division/Department Chair, and the College Dean to determine the equivalence of the course in the other institution to the course in UPV before they recommend approval of the cross-registration.
