However, just like the other residents, eligibility for accommodation for the succeeding semesters shall be subject to the retention policy of the Dormitory.
- 2) Applications of those who have been subjected to discplinary action from previous dorm accommodations will be referred for further evaluation.
- 3) Take note that cooking, laundry, and ironing are prohibited in the dormitories. Tricycle fare (current student rate) within the UPV Miagao campus is Php15.00 per person, for five (5) passengers per trip.
